### DESCRIPTION

### INSTRUCTIONS FOR USE

1 litre of Powerflush Cleaner is sufficient to clean an average sized domestic heating system (100 litres or up to 10 radiators). Badly fouled, heavily sludged or larger systems may require more. If used in conjunction with a powerflush machine, please refer to the unit manufacturer's instructions for use.

Circulate Powerflush Cleaner, preferable at normal operating temperature, with all valves open and the pump turned to maximum flow for a minimum period of one hour or until satisfactory performance is restored. Although it is best to remove the flocculated debris, if it is not practicable to do so, Powerflush Cleaner can be left in and will at least keep the debris moving whilst the pump is on.

No neutralisation is required. Treat with Corrosion Inhibitor afterwards to protect and preserve systems.

**OPEN SYSTEMS:** Dose via header tank (sufficient draining from a low point is required to ensure the entire product enters the circulating part of the system).

**SEALED SYSTEMS:** If the system is empty, add to any convenient part before filling. If full, inject via the filling loop, or other accessible point.
